## Academic Standards

- 1. Scholars are required to maintain a minimum of 2.5 GPA each semester. Failure to maintain this requirement shall result in either academic probation for one semester or removal from the program.
- 2. Any student receiving a grade of D or lower in any class at midterm or the end of the grading period may result in the student being placed on probation for one semester or removal from the program.

Behavior Expectations

  - Unsatisfactory academic progress as related to the program's academic standards or the student's personal improvement plan
  - Skipping class
  - Skipping program-required meetings
  - Skipping state-required testing (SAT, etc.)
  - A level 4 disciplinary referral
  - Attendance and/or tardiness issues
  - Plagiarism
  - Not appropriately representing themselves, their district, or NKU while enrolled in the Academy.
